# *In Loving Memory of Charles Greco*

Charles F. Greco, 88, of Murrells Inlet, SC, formerly of Fairmont and Weirton, WV husband, father, grandfather, brother, uncle and esteemed member of the funeral service community, passed away on Saturday August 12, 2023, in Murrells Inlet, SC. His first wife, Patty will no doubt greet him with class and dignity, with the words, I could have told you...

Charles was born in Fairmont, WV, on December 19, 1934, one of two children born to Anthony "Tony" and Martha "Virgina: DiCea Greco.

Charles graduated from East Fairmont High School in 1952. He had a passion for the Weirton community, and his journey in life was filled with kindness, success, and a profound commitment to helping others in their times of need. He would always say "Throw away your watch and take care of the people."

In his early years, Charlie hitchhiked to Weirton, WV, at the encouragement of Dr. Ray, Victor, Johnny and Joe Greco. There, he started his career at Hertnick's Funeral Home driving the ambulance and service car, in the Summer of 53. It was at Hertnick's Funeral Home that he met Joan Patricia "Patty" Hertnick, whom he married on August 25, 1956. Together, they raised two daughters and a son and were blessed with two grandsons, three granddaughters, and a great-granddaughter.

Driven by a desire to serve, Charles pursued higher education, graduating from West Virginia University and continuing on as a graduate of the Class of 1958 Pittsburgh Institute of Mortuary Science. Alongside his devoted wife Patty, they became the owners and operators of the Greco Hertnick Funeral Home for over 40 years. Under their care and guidance, the funeral home has become an institution in the community, standing for over a century in Downtown Weirton. Their legacy continues through their son, John, who now owns and operates the funeral home and crematory.

In addition to his work in Weirton, Charles owned the Bavington Inn in Bavington, PA. He also expanded his contributions to the funeral service profession, acquiring and managing the Lynch Stacy Greco Funeral Home in Clarksburg, WV. His dedication to the funeral profession extended to his role on the West Virginia Board of Funeral Service Examiners, where he served for 17 years, even holding the position of President of the board. Charles was appointed to the board by 3 West Virginia Governors Moore, Rockefeller, and Caperton. He also achieved the prestigious distinction of being the first West Virginian to serve as President of the International Conference of Funeral Service Examining Boards and the American Board of Funeral Service Education. His firm was invited to join the National Selected Morticians in 1971. The funeral home has been honored with this distinction for over 50 years.



Beyond his professional accomplishments, Charlie will be remembered for his generosity, warm smile, and easygoing spirit. He cherished the company of his friends, sharing countless meals and conversations with them. Whether it was going to breakfast, lunch, or dinner, he treasured every moment of camaraderie with friends like George Huxie – Sarge Mergen, Jimmy Zerkle, John T. Grossi, Bill Marino, Tom Sessi, Chas Marino, Romie Castelli, Don Gianni, Andy DiFonzo, Ed Klee, Emmanuel Starvaggi, Jeff Jezierski, Morris Chijner, Lenny Shaw, Chappy Ballato, Al Lauttamus, Nick Hawley, and Richard Wilburn, just to name a few.

Charlie's life was one of dedication to his friends, and the communities he served. He was always concerned about the funeral home. His daily calls to his son John would always start out with "You busy" and end with "I love you all." His presence will be deeply missed, but his legacy of compassion, service, and camaraderie will continue to shine brightly in the hearts of all who had the privilege of knowing him.

Charles is survived by his daughters, Mary Zick (Jeff) and Michelle Gallaway (Walt), and his son John Charles (Susan) Greco. He also leaves behind his grandchildren W. Michael (Michelle) Bettinazzi, Elle M. and Eliza P. Greco, Jeffry, and Katerina Zick, and his great-granddaughter, Olivia; his sister, Anna Marie Durham; his spouse of the last 15 years Faye Powers and their beloved dog Franklin; his nieces, nephews many cousins.

## In Loving Memory of Dewey Smith Hastings

Dewey Smith Hastings, 97, of Morgantown, died Thursday, September 7, 2023 at Sundale Nursing Home in Morgantown. He was born September 10, 1925 in Morgantown, a son of the late George Dewey and Jeannette Elizabeth (Smith) Hastings.

He was raised on a dairy farm, owned and operated by his family. He graduated from Morgantown High School and was attending West Virginia University when he joined the United States Army Air Force and served during World War II. After his honorable discharge in 1945, he began serving his two year apprenticeship as a funeral director and embalmer at a local funeral home in Morgantown. Upon completion of his apprenticeship, Dewey attended the Pittsburgh Institute of Mortuary Science in Pittsburgh, PA, graduating in 1949 and was a member of the Pi Sigma Epsilon Honorary. Returning to Morgantown after graduation, he married a local girl, Mary Nichols and resumed his work.

With the help of his family, Dewey and Mary purchased the Hardigan property in Morgantown, the site of the first Morgantown hospital. They established Hastings Funeral Home on February 15, 1952.

He was a faithful member of Spruce Street United Methodist Church. Dewey was a member of several civic and fraternal organizations including the Phi Delta Theta fraternity at WVU, Sons of Italy, Sons of the Revolution, IOOF #10 as a 70+ year member, WV Farm Bureau, and Rotary International as a Paul Harris Fellow. Professionally, he was past president of the WV Funeral Directors and Embalmers Association from 1985-86 and was a longtime member of NFDA.

## FROM THE DESK OF ROB KIMES, WVFDCA EXECUTIVE DIRECTOR

As we embrace the arrival of fall, a season marked by transformative shifts in nature, we also recognize the significance of change within our profession. While our daily responsibilities revolve around caring for our client families and managing the operational aspects of our businesses, there are broader changes that affect the way we conduct funeral service today and in the future. As your Association, we are committed to staying informed about these developments and advocating on behalf of our members and the funeral service profession.

In this October 2023 newsletter, we would like to draw your attention to two entities that play a pivotal role in shaping the landscape of our profession: the Office of the Chief Medical Examiner (OCME) and the West Virginia Board of Funeral Service Examiners (WVBFSE).

### **Addressing Concerns with the OCME:**

We have been receiving a steady stream of concern from our members and the public regarding the OCME. Issues such as the time it takes to obtain a completed death certificate from the OCME and the condition of deceased remains upon release to the funeral home have been raised. As your Association, we have taken steps to address these concerns.

Initially, we communicated our concerns to the OCME, seeking solutions. Unfortunately, their response consisted of explanations for the issues but lacked concrete answers on how to rectify them. Subsequently, we approached our legislative representatives, including Delegate Amy Summers, the committee chair for Health and Human Services, and Dr. Sherri Young, who oversees the OCME and Vital Records within the DHHR division. These discussions have allowed us to share our challenges and explore potential corrective measures.

One proposed solution involves establishing an enforced policy for a standard of minimum care of remains, which could significantly reduce issues that funeral homes encounter when preparing the deceased. However, addressing the delays in receiving completed death certificates, some of which have been outstanding for over a year, will require more substantial changes, including the implementation of contingency plans to ensure timely processing. I have been invited to present these issues to the Legislative committee during the October interim session, and I will keep our members updated on any developments.

### **Changes within the WVBFSE:**

The West Virginia Board of Funeral Service Examiners (WVBFSE) plays a crucial role in regulating our profession in the state. In 2022, legislation was passed to introduce a funeral director-only license, permit alkaline hydrolysis, and introduce additional certifications. Subsequently, the WVBFSE was tasked with developing guidelines for the funeral director-only license, amending the code and rules regarding alkaline hydrolysis, and defining education requirements for licensees in charge.

These tasks were incorporated into the guidelines of our profession, with governing rules being passed on April 1, 2023. However, in recent board meetings, there have been discussions about additional changes, ranging from altering the board's name to adjusting administrative fees and fine structures for violations. Of particular concern are proposals related to the presence of a funeral director at funeral services and committal services, with the concept of "general supervision" being introduced. This term implies that a licensed funeral director need not be physically present at these services, as long as they can be contacted.

Furthermore, there are proposed changes related to whether apprentices must be full-time employees of the funeral home during their apprenticeship and whether a funeral director in charge must be a full-time employee of the firm they oversee. These changes could potentially lead to the emergence of "rent a licensee in charge."

It's important to note that while some proposed changes seem routine, others could have a profound impact on our profession. These proposed changes have been discussed at WVBFSE meetings but have not yet been board-approved for submission to the Legislature. We encourage all members to stay informed about the decisions of our licensing boards to ensure that our collective interests are safeguarded.

### **Upcoming Certified Crematory Operator Class:**

Don't forget about the Certified Crematory Operator class scheduled for January 24, 2024, in Charleston. Registration will close on November 17th to allow us to make adequate preparations for meeting space and catering.
